## Distributing food aid to neediest families



Through its program to support the neediest families, the Jafra Foundation in Syria distributed food parcels to a number of households in the Jaramana and Yarmouk camps in Damascus, and the Homs camp.

The campaign targeted households, amid the harsh living conditions the camps are experiencing due to the deteriorating economic situation and the rising prices of commodities. The foundation seeks to alleviate the burdens of affected families by providing basic food items that help meet their daily needs.

The Jafra Foundation is working to expand the scope of distribution to include more needy affected families in these camps, in addition to seeking to reach other camps and areas experiencing similar conditions.

## Intensive training in community development



In collaboration with the Ahl Foundation, the Jafra Foundation organized an intensive training in Beirut, bringing together Palestinian and Lebanese foundations operating in the Palestinian camps in Lebanon, with the participation of the Palestinian NGO Network (Shabaka).

The training focused on developing skills in community organizing and grassroots change, through the exchange of experiences and expertise among participants, and collaborative work that enhances the building of communities.

The Jafra Foundation seeks further collaboration with civil society organizations to develop such initiatives that provide a rich space for dialogue and reflection on a more just and dignified future for the refugees.



The Jafra Foundation mourns the Palestinian writer and activist Ali Badwan, who passed away at dawn on June 2nd, leaving behind a rich legacy of Palestinian political and cultural activism.

Over the years, the deceased participated in the battles defending the Palestinian revolution, particularly during the fascist Israeli invasion of Lebanon in the summer of 1982.

With his passing, the Palestinian Memory Documentation Project loses one of its most prominent figures.

In 1948, on the eve of the Nakba, the occupation forces displaced more than 700,000 Palestinians from their cities and villages to establish a fascist colonial project on the land of Palestine.

Today, more than 6.4 million Palestinian refugees around the world have been denied the right to return to their villages and cities for more than 70 years, while the fascist Hebrew entity continues to expand like a cancerous tumor in the heart of the region.

By highlighting this occasion, the Jafra Foundation reiterates the Palestinian people's right to return, to self-determination, and to live with dignity on their land and the land of their ancestors.

## Gaza's children are deprived of the joy of Eid



With the advent of Eid al-Adha, more than a million children in Gaza are deprived of the joy of Eid due to the bloody war waged by the occupation forces on the Strip. The children of Gaza are living in extremely harsh conditions under bombing, displacement, hunger, fear, and disease.
